- » The Northern Trust Global Sustainability Index Fund (GSIF) seeks to provide long-term growth of principal and income. The results approximate the overall performance of the securities included in the MSCI World ESG Leaders Index.
- » The Fund invests primarily in a broadly diversified portfolio of domestic and international equity securities further diversified by market capitalization, sector, and style. It is suitable for investors willing to accept a greater degree of principal and income volatility for some portion of their assets, in pursuit of long-term growth.

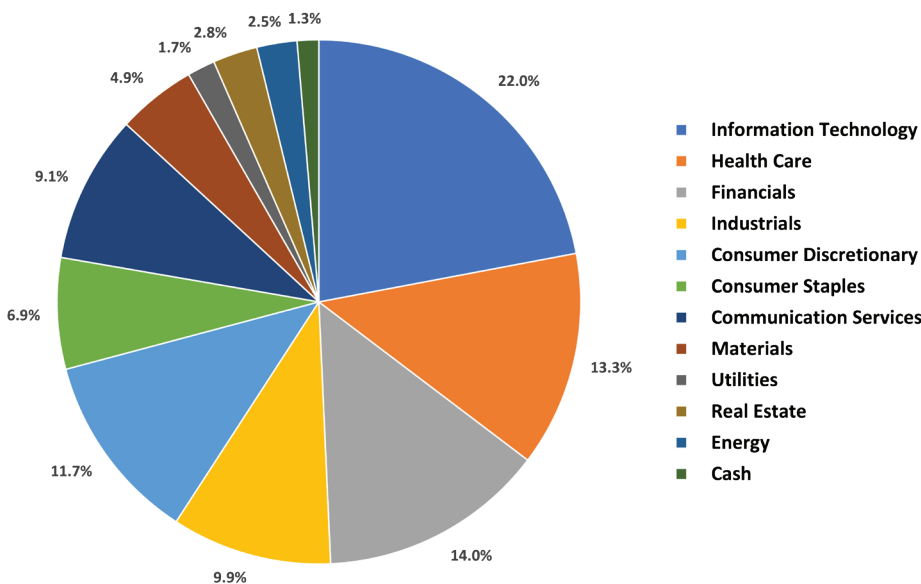

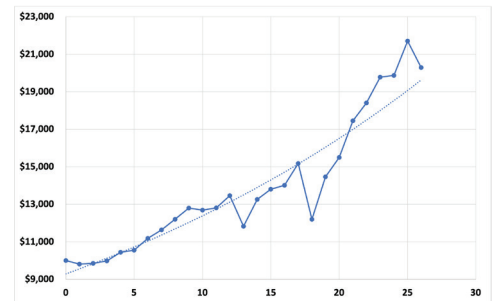
